**HASTINGS BOROUGH COUNCIL
CAR PARK SEASON TICKETS – TERMS OF ISSUE**

Season Tickets are issued subject to Orders made under the Road Traffic Regulation Act 1984 and are subject to the terms below. A person who at any time acts in contravention of, or fails to comply with the following terms, may have their Season Ticket cancelled.

1. Hastings Borough Council reserves the right to refuse to issue a Season Ticket, cancel a Season Ticket or refuse the grant the use of a Season Ticket for a second vehicle.
2. Season Tickets may only be purchased in advance if the new ticket runs on from the date of expiry of an existing ticket without a break in the periods covered.
3. Season Tickets are issued in respect of nominated vehicles only. If a second vehicle is to be used during the currency of the ticket, this is to be declared and noted at the time of purchase. In these circumstances, only one vehicle can be used in conjunction with any one season ticket at any one time. If a temporary/courtesy vehicle is in use, Parking Services must be advised immediately. Non-compliance with the aforementioned will result in the issue of a Penalty Charge Notice. Any faked, defaced, photocopied or altered Season Tickets will be rendered invalid.
4. Valid Season Tickets showing the vehicle registration number(s) must be displayed in the front windscreen of the vehicle. All details printed on the Season Ticket must be clearly visible from outside the vehicle. Failure to display in this manner may result in a Penalty Charge Notice being issued each time the vehicle is left in the parking place.
5. Only the original Season Ticket bearing the genuine, original hologram must be displayed.
6. Possession of a car park Season Ticket enables the holder to park a vehicle at any Hastings Borough Council public car park provided that all the terms of issue are complied with. There are exceptions to this, as follows:-
The Restricted Zone (level 7 and above) and The Reserved Bays in Priory Street Multi Storey, Russell Street Bays, The Country Park, Summerfields, The Pay and Display section of Cornwallis Street Car Park, (Season Ticket area marked in red), Crystal Square, Falaise Hall and Falaise Road which are 4 hour maximum stay car parks, (Priory Meadow and Horntye Park car parks are privately owned, so Hastings Borough Council Season Tickets not valid in either).
7. Vehicles are to be left in marked bays only and must not be parked so as to cause an obstruction.
8. Neither Hastings Borough Council nor its employees shall be responsible for any loss or damage to a vehicle or its contents caused by a third party, unless as a foreseeable consequence of a negligent act or omission of the Council or its employees.
9. Possession of a car park Season Ticket does not guarantee a parking space.
10. There is no refund for the surrender of Season tickets.
11. The Season Ticket is issued in the registration number of the vehicle and is only available for use on that vehicle. In the event of a change of vehicle, a replacement permit for the remainder of the period will be issued free of charge. If a further change is requested before expiry of the permit, we will charge an administration fee of £5.00.
