

Motion to Full Council:

Friendship link between Hastings and Al-Mawasi in Gaza, Palestine

Proposed by: Cllr Yunis Smith

Background:

1. Since 2021, Hastings Friends of Al-Mawasi has been developing friendship links between Hastings and the small farming and fishing community of Al-Mawasi in southern Gaza.
2. In the current conflict, Al Mawasi was designated a 'safe zone' and received thousands of displaced Palestinian refugees. Despite this, it has suffered continuous bombardment, exacerbating an already desperate humanitarian crisis.
3. Throughout this devastating conflict, Hastings residents have been in constant contact with friends in Al-Mawasi and have raised tens of thousands of pounds to support the community there.
4. Members of Hastings' local community, including businesses, community groups, the Trade Union Council and Hastings Mosque, have taken an active part in reaching out to the people of Al-Mawasi in their time of need , including holding regular video calls between the children and young people of our two towns.

The motion

This council believes:

- a) It has been deeply heartening to see thousands of local people respond with empathy and generosity to the terrible plight of people in Al-Mawasi by signing petitions, joining protests and vigils, and writing to their political representatives demanding a ceasefire, as well as raising money for humanitarian aid.
- b) that the friendship link between Hastings and Al-Mawasi is a small but significant public gesture of solidarity, and creates ongoing opportunities for residents of Hastings to engage with the history, culture and daily life of Palestinian people.

This council resolves:

- a) To recognise and support the existing friendship link between Hastings and Al-Mawasi;
- b) To support councillors and council officers to promote the friendship link within the town, working with Hastings Friends of Al-Mawasi to organise exchange trips (when feasible) and other forms of contact between organisations in Hastings and Al-Mawasi.

Note: Support for the friendship link will have no budgetary implications for Hastings Borough Council: activities will be self-funded and organised by participants.

As a resident of Tressell Ward and a founder member of Hastings Jews for Justice (HJJ), I am writing to ask you to give your support to the upcoming motion on Gaza due to be heard this coming Wednesday 16 July.

The slaughter in Gaza has been going on for far too long: the deaths of innocent babies and young children as well as of their parents and relatives is beyond heartbreaking. It has to stop. The public both locally and nationally is desperate for this to stop and is supportive of those who are trying to stop the killing. I am constantly surprised and moved by just how much support there is in Hastings and St Leonards for an end to the fighting and for the UK to stop supplying arms to Israel. In my view therefore HBC needs to respond to the strength of public feeling and pass this motion.

Some have said that Hastings Borough Council (HBC) has no remit to comment or pass motions on matters that are not immediately local. I disagree. HBC has previously made public statements about international matters; they have flown the Ukrainian flag, for instance, in support of that war-torn country, and made formal links with Sierra Leone. Back in the 1980s also, HBC gave a financial grant to support the work of a local anti-nuclear group, DASH, that was campaigning against nuclear power in Dungeness, which is in Kent, and France. So there is precedence.

In addition, Hastings has a well established fellowship link with Al-Mawasi, a small coastal community in the Gaza Strip. We are in frequent contact with the resilience committee there and know first hand just how appalling life is for them. We also know that the support we provide is a lifeline, we hear their exhaustion and their requests that we do as much as we can to end this terrible situation.

For all these reasons, and in the name of common humanity, I am asking you, as my elected ward councillor to give your support to the upcoming motion.


Hello,



I have already received this letter twice.

I have some further information around the folks that the Friends of Al Mawasi (FOAM) are working with in Gaza. They are a grass-roots volunteer organisation who are known as the 'Committee for the Enhancement of Community Resilience' (called the 'Resilience Committee' for short). They set up in 2019 with the aim to provide their own community with services to help them survive under occupation. The group built their own community space which they call 'The Safe Space'.

Since linking up with them in 2021, FOAM helped them raise funds for a new roof, solar panels and internet connection, and supplies for a clinic. They also hold regular Zoom calls between groups of children here and over there, and have linked up families for 'English chats' which help them with their English language – a valuable tool for Gazans to work remotely (examples are web design, teaching English etc).

Just prior to the 7 October attacks, they were about to launch a Women's Project in the space for victims of domestic violence and other vulnerable women, teaching them skills such as basket and soap making in order that they might have an income source. This project was unfortunately shelved and all funds raised since have gone into providing aid such as food, shelter and medical supplies for their community.

All monies raised over here get sent directly to the Chair of the Committee, whom the group have been working with since 2021, and whom they know and trust, for allocation to their current projects. There is no formal 'charity' status.

Full Council Meeting on Wednesday 16th July 2025 - Agenda item 13, motion to be proposed by Councillor Smith

As a constituent of your ward, I am writing with regard to this item.

I believe the motion to be ill-considered and contentious, for the following reasons:

1. This paragraph in no way defines or gives evidence of "catastrophic violence," "suffering," or "humanitarian crisis". How can any discussion be based on such unsubstantiated allegations?
2. The situation in Israel, Gaza and the West Bank is not only complex way beyond what is said here but has nothing to do with Hastings Borough Council's core statutory responsibilities.
3. I have been unable to find any evidence of the legal status and administration of the said friendship alliance. Could you please provide both. If the alliance is a charity, please be aware of the significant risk to the Council of damaging its reputation given that a number of foreign charities provide revenue to Hamas - see <https://www.diplomaticourier.com/posts/hamas-financial-network-for-governing-gaza-strip>

Besides, Al-Mawasi is under Hamas administration. As you will be aware, Hamas is a terrorist organisation dedicated to Islamic Jihad and therefore proscribed under UK law. Moreover, it is fascistic in its treatment of the LGBTQ+ community. And, as a woman, you personally would not be permitted by Hamas to be on any council in any capacity.

4. I am not aware of any way in which the council has fulfilled its duty to me as a Jew within Hastings Jewish Community with the requisite "understanding and tolerance" of my history, culture or ethnicity. On the contrary, I find it very disturbing and distressing to keep encountering the PSC and Hastings Jews for Justice' abrasive street demonstrations. Could you please provide evidence of what the council has done and is doing for me.

Overall, the motion is partisan. For example, why is there no reference to Hamas' attack on Israel on 7th October 2023 and consequent ongoing misery in Israel since then? The motion does not, for instance, take account of the Dinah Project Report - <https://www.bbc.co.uk/news/articles/c1mz8gxzg82o>

Proposed resolutions

1. It is extraordinary for a borough council to arrogate to itself the power to call for a ceasefire of such magnitude currently being discussed by the governments of Israel, the UK, the US, Qatar and others, together with the leaders of Hamas and the Palestinian Authority. What specific authority do you have that they don't have? Do you really conceive that the terrorist group Hamas will respond to Hastings Borough Council by releasing whoever remains of the hostages?

Had Hamas not attacked on 7th October, there would have been no war. Had they

subsequently released the hostages, the war would have been over, and still could be now. Even the Grand Muftis of UAE and Saudi Arabia publicly condemned Hamas' brutality and triumphant aftermath.

How can you, in clear conscience, even appear to condone the entire attack, hostage-taking, and torture of hostages at all? Also what about the bodies and remains of the hostages murdered by Hamas not returned to grieving Israeli relatives?

2. This is laughable. Writing such a letter would have nil effect, whether legal, practical or political. As above, why on earth would the Government listen to Hastings Borough Council? The only achievement would be the Council feeling virtuous. I wish the Council would aim for practicable, local goals – housing, homelessness, pot-holes, GP appointments, and the general wellbeing of the borough - rather than honing slogans to go on t-shirts.

More seriously, it is wicked to seek to deprive a democratic, sovereign state of the means to defend itself.

3. and 4. Again, please provide clear evidence of the legal status of this friendship alliance. And why specifically select friendship with a place in Gaza, rather than, say, in Sudan, Xinjiang, Myanmar or Ukraine?

Could you please explain how in any way Al-Mawasi and generally liberal Hastings could be considered a good match.

I appreciate that no money would be spent in support of this mysterious friendship but I would resent my councillors spending so much energy on this wayward project.

Overall, I find it strikingly curious that some people, including some councillors, in this town are so evidently tunnel-visioned with this project; I see Al-Mawasi leaflets everywhere.

Finally, could you please provide details of any consultation Councillor Smith has undertaken with regard to this motion with the range of Hastings' stakeholders including Hastings Jewish Community.

Accordingly, I ask respectfully that you vote against this motion.
